The members of Independent are seeking a Pastor who is well versed in both the Old and New Testaments and possesses a strong commitment to Biblical Preaching and Teaching. We are seeking an individual whose qualifications align with 1 Timothy 3: 1-7 and Titus 1: 6-9.

Qualifications:

- Licensed and ordained within the Baptist denomination.
- Bachelor's degree earned from an accredited institution and Theological Seminary training preferred.
- A minimum of five years of pastoral experience preferred.
- Effective communication skills (written and oral).
- Ability to deliver God's Word by preaching the Gospel using sermons that are scripture-based and relevant to the 21st century Christian.
- Proficient in operating commonly used technological devices.
